

# **Business Ethics Policy**

AHM Marine L.L.C employees shall maintain the highest ethical standards in the conduct of Company affairs. The purpose of this policy is that each team member will conduct the Company's business with integrity and comply with all applicable laws in a manner that excludes considerations of personal advantage or gain.

The following is a summary of the AHM Marine LLC's policy with respect to

- (1) Gifts, favors, entertainment and payments given or received by AHM Marine Employees,
- (2) Potential conflicts of interest and
- (3) Certain other matters:

### **General Policy Application:**

### A. Gifts, Favors, and Payments by the Company:

Gifts, may be given to others at Company expense, if they meet all of the following criteria:

- 1. They are consistent with accepted business practices
- 2. They are of sufficiently limited value and in a form that will not be construed as a bribe
- 3. They are not in violation of applicable law and generally accepted ethical standards; and Payments, commissions or other compensation to or for the benefit of Employees of customers (or their family members or Employees) are against the company policy and are prohibited.

## B. Gifts, Favors, Entertainment and Payments Received by Company Employees:

1. Team-members shall not seek or accept for themselves or others any gifts, favors, entertainment, payments nor shall they seek or accept personal loans than conventional loans at market rates from lending institutions) from any persons or business organizations that do or seek to do business with or is a competitor of AHM Marine LLC.



- 2. Employees may accept for themselves and members of their families common courtesies usually associated with customary business practices. These include but are not limited to:
- 3. Lunch and/or dinner with vendors sometimes including spouses as long as the invitation is extended by the vendor.
- 4. Gifts of small value from vendors such as calendars, pens, pads, knives, etc.
- 5. Tickets to events (such as sports, arts, etc.) are acceptable if offered by the vendor and the vendor accompanies the associate to the event. These are not to be solicited by the company employees and must be approved by the appropriate company officer.
- 6. The receipt of alcoholic beverages is discouraged.
- 7. Gifts of perishable items usually given during the holidays such as hams, cookies, nuts, etc., are acceptable.
- 8. Gifts, services, discounts, entertainment or considerations of any kind from suppliers is discouraged.
- 10. Use of vendor's facilities (vacation homes, etc.) by Employees or families for personal use is prohibited.
- 11. It is never permissible to accept a gift in cash or cash equivalent such as stocks or other forms of securities of any amount.
- 12. Management Employees should not accept gifts from those under their supervision of more than a limited value.

## C. Conflicts of Interest:

Employees should avoid any situation which involves or may involve a conflict between their personal interest and the interest of the Company. As in all other facets of their duties, Employees dealing with customers, suppliers, contractors, competitors or any person doing or seeking to do business with the company are to act in the best interest of the company. Each associate shall make prompt and full disclosure in writing to their manager of any potential situation which may involve a conflict of interest. Such conflicts include:

 Ownership by associate or by a member of their family of a significant interest in any outside enterprise which does or seeks to do business with or is a competitor of the company.



- 2. Serving as a director, officer, partner, consultant, or in a managerial or technical capacity with an outside enterprise which does or is seeking to do business with or is a competitor of the company.
- 3. Acting as a broker, finder, go-between or otherwise for the benefit of a third party in transactions involving or potentially involving the Company or its interests.
- 4. Any other arrangements or circumstances, including family or other personal relationships, which might dissuade the associate from acting in the best interest of the company.

### D. Confidential Information:

The revelation or use of any confidential product information, data on decisions, plans, or any other information which might be contrary to the interest of the Company without prior authorization, is prohibited. The misuse, unauthorized access to, or mishandling of confidential information, particularly personnel information, is strictly prohibited and will subject an associate to disciplinary action or immediate discharge

## E. Compliance:

Any violation of this policy will subject the associate to Administrative disciplinary action or immediate discharge. Any Company employee having knowledge of any violation of the policy shall promptly report such violation to the Manager- Human Resources. Each Dept head is responsible for compliance in their area of responsibility. When questions arise concerning any aspect of this policy, contact the Manager - Human Resources
